EUROFOREST 2023

PREAMBLE

These regulations supplement the General Rules for business events, available on the event website: www.euroforest.fr. Exhibitors have read and understood the General Regulations for business events and the Euroforest 2023 Specific Regulations.They agreed to comply therewith. In the event of a conflict of interpretation between two similar provisions, the Specific Regulations shall take precedence over the General Regulations.

Article 1: The organization

Euroforest is a brand which belongs to the Association of the same name, made up of Fibois Bourgogne-Franche-Comté (forestry and wood inter-trade body for Bourgogne-Franche-Comté) and CFBL (forestry cooperative). The organization and marketing of the exhibition shall be done by Euroforest:

Euroforest 2023 will take place at Saint-Bonnet-de-Joux (département 71 - France) and will be open to the public on Thursday 22 June 2023 from 09:00 to 18:00, on Friday 23 June from 09:00 to 18:00 and on Saturday 24 June from 09:00 to 17:00.

Article 2: Conditions for being an exhibitor at Euroforest

2.1 Be a supplier

Each exhibitor can be supported by its local distributor on condition that the latter is representing the brand. All equipment and services at the Euroforest exhibition must have a direct link with the forestry/wood industry. Admission is at the discretion of Euroforest, which is under no obligation to give the reasons for its decisions. The rejection of a registration form by the organisational committee shall not give rise to any compensation or damages, only participation costs will be reimbursed. This does not include the application fees, which shall remain the property of Euroforest.

2.2 Send the registration form

The registration form, accompanied by an exhibitions and fairs Public Liability insurance certificate, must be sent to Euroforest by 31 January 2023. Registration will only be final after examination of the application and acceptance by Euroforest's management committee, which may refuse any application without giving reasons for its decision. Registration will only be final when full payment for the registration fees and the services requested by the exhibitor has been received.

Article 3: Registration – Payment – Allocation of stands – Withdrawal

3.1 Registration and payment

As indicated in the registration form, the registration and exhibitors' services fees are to be paid in three instalments:

• 30% at the time of registration.

A pitch will be reserved upon payment. It will be reimbursed if the applicant is not accepted as an exhibitor and shall remain the organiser's property if the applicant cancels.

• 70% by 31 March 2023 at the latest.

In the event of payment after the due dates, the organiser reserves the right to rent the pitch to other exhibitors.

3.2 Stand allocation

Acceptance of the application does not confer any right to occupy a specific pitch. Participation in previous events does not confer any right on exhibitors to a specific pitch. The organisers shall determine pitches as they see fit, taking into account the wishes expressed by the exhibitors as far as possible.

3.3 Withdrawal

In case of withdrawal before 15 April 2023, the amount of the deposit will remain acquired. After this date, the full amount of the participation will remain payable as damages even in the event of relocation of the site to another exhibitor.

Article 4: Occupation and use of the stands

Subletting of all or part of the space that you have reserved, even free of charge, is strictly prohibited. As a result, exhibitors can only present products and only distribute documents in their name. The layout of the stands must be completed by Wednesday 21 June at 20:00. Exhibitors are required to occupy their stand and open to the public from the first opening time until the closure of the exhibition (see Article 1 for the opening hours). The products on display must be placed in public view during the same times. During the Euroforest exhibition, exhibitors may promote their products with documents, posters, panels and banners inside the exhibition perimeter. Outside the exhibition's exhibition space and within the of the Euroforest site perimeter, any distribution of documents must be contractually agreed with the organisers and shall incur a fee (see the offers in the registration form). For other requests please consult the organisers.

Article 5 : Safety

5.1 Demonstrations

Exhibitors are responsible for the safety of their staff and visitors during demonstrations. They should therefore take all necessary precautions in this regard and take out an insurance policy covering the risks of demonstration in a public place (a certificate must be supplied). All demonstrations should be carried out with constant care and in compliance with the forestry work safety rules. The staff provided to Euroforest to monitor site safety may at any time stop the demonstrations and expel any person whose behaviour may prove dangerous.

5.2 Security

All the roadways going into the site shall be closed off with barriers. The organising committee shall set up a security service outside opening hours, from Thursday 15 June at 19:00 until Monday 26 June at 12:00. No vehicle will be allowed to enter or leave the site during opening hours.

SPECIFIC REGULATIOS EUROFOREST 2023 - 22-24 JUNE 2023 SAINT-BONNET-DE-JOUX (71) - BOURGOGNE-FRANCHE-COMTÉ – FRANCE

Article 6: Protection of the forest

Lighting fires is strictly forbidden. All precautions must be taken by exhibitors to ensure the utmost respect of the forest around them. Demonstrations of logging equipment must be done in compliance with the general clauses appearing on CFBL's sales documentation, which are available from the organising committee. With regard to any damage to standing trees: any tree not marked for removal which is used or damaged shall incur the payment of compensation to the owner of the forest equal to $\in 100$ per tree.

Article 7: Insurance

7.1 Euroforest's insurance

Euroforest has taken out an insurance policy covering its public liability as organiser. Damage and spoilage resulting from accidents caused to the exhibitors' goods, for which the organiser is liable (installation, dismantling), are covered by the said insurance. Exhibitors must have public liability insurance against the risks of fire, water damage or theft of their equipment, and against third party claims. Euroforest cannot be held liable for these risks. In the event of a claim, the exhibitor states that it waives any legal action against Euroforest. The following cover is excluded: Exposed goods left without supervision during the opening hours of the event and during the installation and dismantling days, vehicles subject to compulsory insurance, and damage caused by natural disasters.

7.2 Accidents

In the event of an accident of any kind, the exhibitor must immediately inform Euroforest's organising committee and confirm its declaration within a period of 24 hours by Registered Letter with Acknowledgement of Receipt. In the event of theft, the exhibitor must also submit a complaint at Charolles gendarmerie within 12 hours and send the receipt within 24 hours to Euroforest's organising committee. The organiser cannot be held liable for accidents that have not been declared using the forms indicated above or for any events that have arisen.

7.3 Force majeure events

In the event that a fire, storm, war, public disaster, pandemic or a force majeure event makes it impossible to run the Euroforest exhibition, Euroforest's organising committee may cancel registered applications for pitches at any time by notifying exhibitors in writing. Exhibitors shall not be entitled to any compensation or indemnity. Any remaining funds available after payment of all expenses incurred shall be divided among the exhibitors in proportion to the sums paid. They expressly agree not to take any legal action against the organising committee in any capacity or for any reason whatsoever.

Article 8 : Set-up and dismantling of stands

8.1 Delivery of equipment to the site

All of the exhibitors' equipment and products must be delivered between Thursday 15 June at 08:00 and Wednesday 21 June at 19:00 so that they can be put in place in the exhibition and demonstration area. All exhibitors, or their representatives, shall arrange the transport, receipt and shipping of their packages or other consignments, as well as acknowledgement of their content. All packages or other consignments must be unpacked on arrival. If the exhibitors or their agents are not present to receive them, the organisers cannot be held liable for unloading and storing the equipment.

8.2 Unloading of equipment and set-up

The unloading of all equipment is free on Thursday 15, Friday 16 and Saturday 17 June 2023. On Monday 19 and Tuesday 20 June, equipment will be handled by prior reservation only and will be billed (see registration form). No equipment will be handled on Wednesday 21 June (the day before the exhibition). Exhibitors are required to comply with the professional charter during set-up and dismantling, in order to organise and ensure the health and safety of employees working together during set-up and dismantling of the trade stands (available on the Euroforest.fr website). In the event of unfavourable weather conditions, exhibitors agree to follow the instructions given by the organiser.

8.3 Checking the installations

The organization reserves the right to have installations removed or modified that would harm the general appearance of the event or disturb neighboring exhibitors or visitors.

Exhibitors with one or more tents with a surface area greater than 9 m², not ordered from Euroforest, must provide the extract from the security register no later than May 15, 2023 and no later than Thursday 15 June the assembly certificate(s) for marquees over 18m2 and the M2 certificate of conformity for the envelopes of any tent regardless of their surface.

8.4 Dismantling of stands

Stands may not be dismantled before Saturday 24 June at 18:00. Exhibitors' vehicles may only use the pathways after all the visitors have left. Exhibitors or their representatives are required to remain with their stands from the start of dismantling until they are completely removed. Small pieces of equipment must be removed by the exhibitor at the end of the event. Exhibitors must return any rented equipment in the condition in which they found it. Any damage caused by their installations or merchandise shall be at their expense.

Pitches must be completely vacated by 18:00 on Monday 26 June at the latest. After this date, the organisers reserve the right to have any equipment remaining on the land removed, at the expense and risk of the exhibitor, and shall not be held liable in the event of theft.

For any issues not covered by the regulations, it is up to the organisers to make decisions which they deem appropriate.

All decisions shall take immediate effect.
